2. Subject to the **BCWA Grape Grower Registry Rules**, one copy of this form is to be submitted to the British Columbia Wine Authority office, completed accurately and signed by an authorized signatory by August 1<sup>st</sup> of each year. Failure to do so could result in the Grower being disqualified as a registered grower for that year's vintage and may also disqualify the Grower's production for use in any BC Wine of Distinction.
3. **By submitting this application for registration the Grower:**
  - a. Warrants that all information provided in this application is complete and accurate;
  - b. Agrees to maintain accurate and complete records as required by the British Columbia Wine Authority under the BCWA Grape Grower Registry Rules;
  - c. Agrees to permit the British Columbia Wine Authority to conduct an inspection on such records to confirm the accuracy of the records; and
  - d. Agrees to comply with the BCWA Grape Grower Registry Rules in effect as of the date of this application.
