## Application For First Level Laboratory Certification

1. By submitting this application the applicant laboratory:
  - a) Agrees to the terms and conditions of the British Columbia Wine Authority's first level laboratory certification system as set out in the Authority's Rules Concerning First Level Certification of Laboratories;
  - b) Warrants that all information provided in this application is complete and accurate;
  - c) Confirms that it has the ability to perform the tests required under Section 23(2) of the *Wines of Marked Quality Regulation* as it has indicated in Part 3 of this application and agrees to comply with the applicable methodology for each such test as set out in the AOAC Official Methods of Analysis or as otherwise indicated in Part 4 this application;
  - d) Agrees to maintain accurate and complete records as may required by the British Columbia Wine Authority, from time to time; and
  - e) Agrees to permit the British Columbia Wine Authority to inspect the laboratory's facilities and to conduct audits on records required to be maintained by the laboratory.
2. The application fee for initial certification applications is \$200. The application fee for renewal applications is \$100. The applicable application fee must accompany this application.
3. If this application is approved, the laboratory's certification will be valid for a period of one calendar year (January to December). The laboratory must apply annually to renew its First Level Certification.
4. Any failure to maintain complete and accurate laboratory records or any failure to grant reasonable access to the British Columbia Wine Authority to those records for audit purposes or to the laboratory's facilities for inspection purposes will result in a cancellation of the laboratory's First Level Certification.
5. The information provided in this application is kept confidential by the British Columbia Wine Authority and is only used for purposes of administering the *Wines of Marked Quality Regulation*.
